January 1, 2025 launch date for ICRIME Production.

NIBRS User Manual and Iowa UCR Manual will be referenced beginning **January 1, 2025**.

LEOKA PROCESS

LEOKA identified with UCR uploads report **assaults** via NIBRS.

LEOKA application identified through LEEP portal used for **felonious/accidental deaths**.

FORM SENT FOR ADDITIONAL AREAS

entered on portal by UCR Staff



NEW SUBMISSION DATE

Beginning **November 2024**, FBI will release **monthly** submissions for state crime data on Crime Data Explorer.

Iowa UCR Program Policy will be adjusted to:

*Data from the previous month must be processed in ICRIME by the **tenth (10th)** day of the current month.*

**no later than
the fourteenth (14th)**



IOWA CODE 692.15

Incidents and reports shall be reported no later than 35 days.

DATA UPDATES

All modifications or changes made to previously submitted cases need to be submitted with monthly uploads.

Audits being completed are identifying this gap as agencies are not pulling modified cases when building files.

Impacts agency and overall crime data statistics.



TRACS RESOURCE GUIDE

Pulls up contact information as well as a link to the **Quick Reference Guide** as it relates to TraCS.

STATUTE CODES

New version of spreadsheet to include all repealed codes.

Available when updates are made on the DPS public site as well as the ICRIME Production and Test Sites.

Always noted with the date of most recent changes.



SAFE AND SOUND APPLICATION

Application monitors web and social media devices.

Agency notified of potential threat; likely 13C - Intimidation.

Crime Against Person:

Victim **must be** individual or LE officer.



GOALS

Audits are more important now than ever due to monthly data releases by FBI.
